5. BUSINESS ASSISTANCE ORGANIZATION(S)

- Leslie Parks (Director of Downtown and Industrial Development) and Bill Ekhern of San Jose Redevelopment Agency
- Leslie Parks: the Agency is currently focused on retention/helping businesses retrench. Some programs include:
 - i. Enterprise Zone (State tax benefit)
 - ii. Technical Assistance
 - iii. New Restaurant Consultant (includes a boot camp)
 - iv. Business Needs Assessment to begin shortly
 - v. Small Business Ambassador Program (Development process assistance)
 - vi. Sign Grant (to business) and Façade Improvement Programs (to building owner)
 - vii. Neighborhood Business Districts (Alum Rock, East Santa Clara, Winchester...)
 - viii. The eCenter is partially funded by the Agency
 - ix. Business Owner Space is funded by Federal funds
 - x. Website being revised
- Bill Ekhern:
 - i. Façade Improvement Program
 - ii. Sidewalk café support
 - iii. Smart Start Grants (physical improvements) daycare center - \$2 million in grants
 - iv. They work with architects and various specialist consultants.
 - v. Roughly every two years they review their lists.
 - vi. Looking for ways to utilize smaller firms for smaller projects.

- vii. Smaller businesses do have trouble breaking into public work due to insurance, bonding and paperwork requirements (roughly \$10 million in small construction projects)
- viii. Also larger projects offer subcontracting opportunities
- ix. San Jose Foundation is now running the Incubator Program
- x. The Environmental Business Incubator is very successful
- xi. Green Jobs are growing here

6. FEE FOR BUSINESS TAX COLLECTION

- Deputy Director Dave McPherson presented information about the new fee.
- Council approved fee in June 2008
- Tax hasn't changed in 35 years
- Fees allowed for increased customer service
- Move collections staff away from clerical allowed collections to go from \$1.6 TO \$10
- Fee and Tax make allowances for hardship
- Also have streamlined to allow low-income to do a in-lieu hardship which allow them to avoid submitting
- Los Angeles collects \$400 million in business taxes

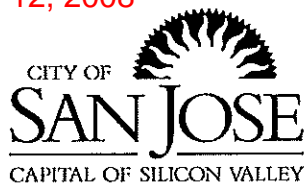
